Sl. No.	The school is directed to ensure that :
1	The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively). The total number of sections of the school from class I to XII shall be restricted to 18 of which not more than 1/3rd sections may be used for senior secondary classes. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by law and availability of class rooms of greater than 500 sq ft dimension.
2	The school is not running bal-vatika. Thus, it is required to submit an undertaking on its letterhead that it will run the bal-vatika in the upcoming session within 03 months in the compliance.
3	The composite science lab is does not have gas connection in the workstation, seating arrangement (wooden stools), sufficient storage facility and safety features such as fire extinguisher and exhaust fan. Further, there are side slabs which have been constructed adjacent to the wall, which is not appropriate for conducting practical's. Thus, the school is required to set-up in light of the Board's SoP within 03 months and submit the compliance.
4	The library is under stocked and does not have separate reading space for staff. Thus, the school is required to upgrade the same in light of the Board's SoP within 03 months and submit the compliance
5	The school is required to develop its playground /campus within 03 months and submit the compliance.
6	The school shall conduct training of its teachers with CoE Prayagraj within 03 months and submit the compliance

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

- 5. The school shall renew mandatory certificates from time to time.
